Shall the resolution of the Board of Fire Commissioners adopted on the 16th day of May, 2018,

PROPOSITION #1 Shall the resolution entitled: "A RESOLUTION AUTHORIZING PARKING LOT PAVEMENT REPLACEMENT AND THE INDEBTNESS IN THE AMOUNT OF ONE HUNDRED AND FIFTY THOUSAND DOLLARS (\$150,000) OF THE NORTHUMBRLANF FIRE DISTRICT #1 FOR THE REPLACEMENT OF THE PAVEMENT IN THE PARKING LOT"

RESOLUTION #1 2018

A RESOLUTION AUTHORIZING THE BOARD OF FIRE COMMISSIONERS OF THE NORTHUMBERLAND FIRE DISTRICT #1, TOWN OF NORTHUMBERLAND, SARATOGA COUNTY, NEW YORK, TO EXPEND MONIES FROM THE GENERAL RESERVE FUND.

1. BE IT RESOLVED. By the Board of Fire Commissioners of the Northumberland Fire District #1 in the Town of Northumberland, Saratoga County, New York, as follows:
2. Section 1. The Board of Fire Commissioners is of the opinion the parking lot of the Gansevoort Firehouse located at 1870 RT32N, Gansevoort, NY is in need of replacement.
3. Section 2. That it is determined that the monies to be expended on this project shall not exceed \$150,000 (one Hundred fifty thousand dollars) from the General Reserve Fund.
4. Section 3. This resolution is adopted subject to a permissive referendum.
5. Section 4. This resolution passage was moved by Chairman Tim Colozza and Commissioner James Warrington seconded motion. Commissioners Colozza, Wood, Applegate and Warrington voting yes, the motion was approved 4 o 0.
