Supervisor Willard Peck stated that Jeffrey Crum, Shop Steward, for the Highway Department employees, asked if Vacation Time could be carried over into 2021 in excess of the 40 hours per the Agreement between the Town of Northumberland and Teamsters Local 294. Supervisor Peck stated that Saratoga County Board of Supervisors previously adopted a Resolution allowing County employees to carry over the maximum hours outlined in their Contract due to COVID-19 as a one-time exception.

Councilman John DeLisle introduced Resolution #65 of 2020

WHEREAS, the Agreement between the Town of Northumberland and Teamsters Local 294 states in Article 9 – Leaves/(A) Vacation Section 4 “Vacation credits may be accumulated up to forty (40) hours and carried to the next year if not used the year earned and

WHEREAS, New York State was in “Pause” for months which greatly limited what the New York residents could do outside of their home which limited vacation.

BE IT RESOLVED, with COVID-19 extremely limiting what a Highway Employee could do during “Pause”, the Town of Northumberland Town Board approves, a one-time waiver, that the vacation credit may exceed the forty (40) hours that can be carried over into 2021.
